## **China-Latin America Youth Entrepreneurship and Innovation**

### **Program and Innovation Tour in China for Latin American Young**

### **Scientists**

#### **I. Event Background**

##### **1. Introduction to the Organizer**

China-LAC Technology Transfer Center (hereinafter referred to as the “Center”) is the only national-level technology transfer institution focused on Latin America and the Caribbean region, approved by the Ministry of Science and Technology of the People’s Republic of China. Guided by the “Platform-Network-Mechanism” development paradigm, the Center establishes a multi-dimensional China-LAC technology transfer system, actively facilitating the economic development, sci-tech innovation exchanges and cooperation, as well as technology transfer between China and LAC countries, and advancing China-LAC relations characterized by equality, mutual benefit, innovation, openness, and benefiting the people in the new era.

##### **2. Event Objectives**

This program focuses on the theme of technology-enabled production and enterprise digital transformation, establishing an innovative “Online Training Camp + Offline Training Program” incubation system to provide innovation and entrepreneurship training courses for young Latin American talents, invite outstanding participants for the Innovation Tour in China, and foster collaboration among Chinese and LAC universities, research institutions, and enterprises. It is dedicated to developing long-term partnerships, jointly advancing scientific research projects, talent development programs, and technology transfer initiatives to achieve resource sharing and complementary advantages, further deepening China-LAC sci-tech cooperation.

#### **II. Target Participants**

The program targets outstanding young talents from Latin American countries, with priority given to PhD candidates, young scientists and entrepreneurs, etc. The selection focuses on identifying and supporting young talents with innovative thinking and entrepreneurial potential. The program will admit 20-30 participants, with an age limit of 45 years old.

#### **III. Program Structure**

**1. November 15, 2025 – February 15, 2026 — Online Innovation and Entrepreneurship Training Camp:** Featuring fundamentals of innovation and entrepreneurship, startup practice, business ethics, international business, etc.

**2. March-April 2026 — Offline Innovation Tour in China:** Under the theme of

“Technology-Enabled Production and Enterprise Digital Transformation,” the program will organize field study visits to Dongguan, Guangzhou, Zhuhai, and other cities in Guangdong Province for hands-on exchange and learning.

#### **IV. Training Plan**

**1. Credit Requirements:** Participants are required to complete 5 compulsory courses and take 3-4 elective courses (see Attachment 1 for the full course list).

**2. Curriculum Design:** The courses primarily focus on comprehensive skill development, covering topics such as innovation and entrepreneurship practice, business ethics and sustainable development, and international business negotiation techniques.

#### **(V) Assessment Criteria**

##### **1. Online Innovation and Entrepreneurship Training Camp:**

(1) A written reflection paper with minimum 2,000 words covering insights from online courses and program activities.

(2) A business proposal, including project introduction and objectives for the China program.

**2. Offline Innovation Tour in China:** Based on comprehensive evaluations including interviews and online course performance, 30 outstanding participants will be selected to join the Offline Innovation Tour in China. Qualified candidates shall submit required documents to the organizer’s designated email upon receiving official invitations.

#### **VII. Registration Requirements**

##### **1. Language Proficiency**

The training program will be conducted in **English**. Participants are required to have strong English listening, speaking, reading, and writing skills.

##### **2. Health Requirements**

(1) Good physical health is required. For the Offline Innovation Tour in China, participants are required provide a health certificate or medical examination report issued by a local public hospital.

(2) Participants must not have any diseases prohibited by Chinese laws and regulations from entering the country, including but not limited to severe hypertension,

cardiovascular and cerebrovascular diseases, diabetes, or other serious chronic illnesses, mental disorders, or infectious diseases that may pose a significant public health risk. They must not be in a post-major-surgery recovery period, an acute illness episode, suffering from severe physical disabilities, or in pregnancy.

### **VIII. Cost Requirements**

**1. Online Innovation and Entrepreneurship Training Camp:** The organizer shall cover participants' online course fees.

**2. Offline Innovation Tour in China:** The organizer shall cover participants' training-related expenses during their stay in China, including accommodation, meals, airfare to China, and learning materials. However, visa fees, medical examination costs, and any non-training-related expenses in China **shall not be covered**.
